#### Bruce Allardice: The Vote to Win the War: The Election of 1864

What was the best chance the South had to win the Civil War? It is generally agreed the South could not win the war in the classic military sense, with Southern armies seizing Washington D.C. and dictating a peace. Many historians have advanced the notion that all the South had to do was to hold on until the North tired of the war and quit.

But even if the Northern population did weary of the war, to the point where they preferred peace to disunion, how could that public sentiment have found expression in government action? It is a given that Abraham Lincoln had no intention of voluntarily ending the war until the seceding states had been brought back into the Union--brought back by persuasion if possible, by force if necessary.

The 1864 election was a desperate (however slim) chance for the South to realize its independence, even if they could not win it militarily. If antiwar activists ever became a majority in the Northern states, Lincoln, or any president so determined, could and would have ignored that popular sentiment so long as he was in office. Some authorities have expressed their belief that the presidential election of 1864 was the only chance for an antiwar Northern public to replace the

Lincoln administration with one devoted to making peace with the South.

Bruce Allardice will examine the 1864 election, whether there ever existed a realistic chance for an antiwar, "peace" candidate to be elected president, and whether that president could have changed the outcome of the war. The presentation will focus on the parallels between the 1864 elections and other elections, the differences in voting between 1864 and the present day, the nomination of George McClellan by the Democrats, and the political nature of the Northern antiwar movement.

Bruce S. Allardice is the past president of the Civil War Round Table of Chicago. His first book, *More Generals in Gray* (LSU Press, 1995), was a selection of the History Book of the Month Club. He is the coauthor of *Texas Burial Sites of Civil War Notables* (Hill College Press, 2002), and has an essay in *Louisianans in the Civil War* (U. of Missouri Press, 2002). He has numerous articles published in magazines such as *America's Civil War*, *Civil War Times Illustrated*, and *North & South*. His latest book, a biographical encyclopedia of Confederate army colonels titled *Jeff Davis's Colonels*, is scheduled to be published this October by Ironclad Publishing. Mr. Allardice, who teaches history, is a graduate of the University of Illinois and the University of Illinois Law School.

## Shiloh: The Battlefield II

Of the Federal units around Pittsburg Landing, William T. Sherman of Ohio commanded one of two divisions to the west of the Eastern Corinth Road which divided the encampment area nearly in half north-to-south. Sherman was a West Point-trained professional, even though he had been out of the army when the war began. He had commanded a brigade at Bull Run effectively without distinction, but suffered a breakdown when in command of the forces in the Cumberland Valley late in 1861. He was restored to service only weeks before Shiloh, and commanded the green 5th Division consisting of some 8,500 Ohio and Illinois troops.

The other division west of the road was the 1st Division of nearly 7,000 Iowa and Illinois veterans of the Henry/Donelson campaign, commanded by John A. McClernand. McClernand had been congressman for Abraham Lincoln's district for some twenty years, and

had been appointed to appease Democratic political interests. McClernand was pompous and selfish and distrusted professional soldiers. He claimed credit for the work of others (notably Grant), but was bold and intelligent enough to at least look competent as a commander. A major general just under Grant's seniority, his military experience before Donelson had been in the Black Hawk War thirty years before. He also had ambitions, as did many such officers, of using his war record as a stepping-stone to higher political office.

### Concept Plans for new Civil War Museum to be Unveiled April 2

A special presentation will be held at 1 p.m., Saturday, April 2, on concept plans for a new Civil War Museum to be opened at Kenosha in 2007. The presentation will be in Daimler Chrysler Hall at the Kenosha Public Museum at 5500 First Avenue.

The theme of the new museum will be "Hearts Touched By Fire: The American Civil War and the Upper Middle West." The facility will be located on the Kenosha lake front and will highlight the roles played by Wisconsin, Illinois, Minnesota, Illinois, Indiana and Michigan in 1861-1865.

From Interstate 94, take Highway 158 east into Kenosha. Where 158 ends at a T-intersection, turn right (south) to the first stop sign, then left (east) to First Avenue. The museum is located on the Lake Michigan shoreline.
