Richard McMurry: “Forty Years to a New Framework for the Civil War”

Our September speaker, Richard McMurry is one of the nation's leading Civil War scholars. He has spoken in Milwaukee several times over the years. His emphasis on Western Civil War historiography has brought that theater out into full view. He received the B. A. degree in history from the Virginia Military Institute, and his M. A. and Ph. D. degrees from Emory University.

He has taught history at Valdosta State College (Georgia) and North Carolina State University. Since 1988 he has been a freelance writer and speaker and has served as a guide/historian for many tour and cruise groups. He has written more than one hundred articles on various facets of the war, and he is the author of *Two Great Rebel Armies; Fourth Battle of Winchester*, and *Towards a New Civil War Paradigm; VMI Alumni in the Civil War* and *Atlanta 1864*. He is a member of numerous historical societies and is active in such organizations as the Civil War Preservation Trust and the Blue and Gray Education Society.

The Rail Splitter, a national organization of Lincoln and Civil War collectors, is now hosting a huge auction of Lincolniana and Civil War memorabilia that concludes on September 15th. With more than 1,200 lots, this represents the largest sale of historical artifacts, documents and material related to Abraham Lincoln and the Civil War since the Oliver Barrett Collection was dispersed by Parke Bernet Galleries in 1952.

Sunset Gun — Summer 2005

This has not been a good summer for the Milwaukee Round Table, and for Civil War scholarship in general. June alone claimed Brian Pohanka, Shelby Foote, and Mike Marinelle.

The organizations we study accepted death as a matter of routine. We do not.

Brian C. Pohanka, 50, a Civil War historian who advised filmmakers, preserved battlefields, reenacted troop movements and dressed the part, died of cancer 15 June at his home in Alexandria.

As an adviser and military coordinator on major motion pictures, including *Glory* (1989) and *Cold Mountain* (2003), he ensured the historical accuracy of films that would be seen by millions in theaters and on television.

So immersed was he in the Civil War era that he trimmed his beard in a style called the Imperial, popular in the 1860s. One of the legions of Civil War reenactors in the area, Mr. Pohanka served as captain of the 5th New York Infantry. When he donned its red-and-gold trimmed Zouave, or French-style, uniforms, the dapper historian looked as if he had stepped out of history.

Novelist and historian **Shelby Foote**, whose Southern storyteller's touch inspired millions to read his multivolume work on the Civil War died

27 June, his widow Gwyn, said. He was 88.

Foote, a Mississippi native and longtime Memphis resident, wrote six novels, but is best remembered for his three-volume, 3,000-page history of the Civil War, and for his appearance on the PBS series *The Civil War*. He worked on the book for 20 years, using a flowing, narrative style that enabled readers to enjoy it like a historical novel.

"I can't conceive of writing it any other way," Foote once said. "Narrative history is the kind that comes closest to telling the truth. You can never get to the truth, but that's your goal."

Foote's soft drawl and gentlemanly manner on the Burns film made him an instant celebrity, a role with which he was unaccustomed and, apparently, somewhat uncomfortable.

Michael Marinelle was a member of the Round Table since 1997, a veteran of the "forgotten" Korean conflict, and an active voice of the membership to the Board. According to his widow, Barbara, M² (his e-mail signature) died of leukemia-related causes on 6 June. His quick wit, boundless energy and endless supply of jokes will be missed by this correspondent. As his wife said, maybe he just went skiing.

Maybe they all did.

Shiloh — The Hornet's Nest I

The April 1862 battle of Shiloh was a line of departure for the US Army. At the encircled salient called the Hornet's Nest, the US Army began a long transformation from a frontier constabulary and citizens militia to a unified, professional army, and set the tone for American resilience under fire.

Powell and his patrol engaged the Confederates at the Frawley Field in the early morning hours. To the north and west of this action, troops of William Sherman's Fifth Division fell into line at about 0700, two hours into the battle, just outside their camps in the northeast corner of the Rea field, when Sherman suddenly realized he was under heavy attack.

Some fifteen minutes after this Ulysses Grant, commanding the army, heard the guns

while eating breakfast on his headquarters at Savannah nine miles downriver. He ordered William Nelson, commanding a division from the Army of the Ohio, to march upriver to a landing opposite the Pittsburgh Landing so they could be ferried across. Nelson's troops were under the command of Don Carlos Buell of the Army of the Ohio, but Nelson agreed to get his men moving as soon as he could.



To the east, a colonel rode through a camp on a foam-flecked horse shouting that the fighting on the right for over an hour. The regiment quickly assembled and nearly as quickly was firing at Confederates coming through the woods. This was the first that Benjamin Prentiss, commanding the Sixth Division, knew for certain of a general attack.
